

# New Zealand-China Tripartite Partnership Fund

## Guidance and Call For Proposals

*Support funding is available for new and existing tripartite relationships between New Zealand and Chinese universities in 2022.*

*There are two documents:*

- 1. This Guidance document that outlines the purpose of the fund, invites proposals that fit the brief, and outlines the process for how proposals will be selected for funding. The fund is competitive.*
- 2. The Proposal document, which is to be used to prepare and submit your funding application.*

### Background

In 2005, the Chinese Ministry of Education initiated a partnership programme, also known as the 'Two Brothers' arrangement, between prestigious eastern universities and universities in developing western inland areas.

The New Zealand and Chinese Ministries of Education subsequently agreed to formally support and promote tripartite relationships between New Zealand and China, in which a New Zealand university is joined as the 'third brother' to an existing 'two brothers' arrangement. Both governments have further agreed to commit funding to support this bilateral initiative.

Under the terms of the May 2017 Addendum to the Arrangement on Cooperation in Education and Training Between the Ministry of Education of New Zealand and the Ministry of Education of the People's Republic of China, the following subject areas are eligible for Tripartite Fund support: arts, humanities, social sciences, sciences and applied sciences.

### Purpose of the Fund

The purpose of the fund is to encourage the development of strategic research relationships between New Zealand and China. It seeks to help initiate new tripartite partnerships and facilitate the development of existing partnerships.

Funding is available for costs associated with facilitation or development of the research partnership, which is the main objective of the fund. Previously the fund has been used to support meetings, mobility, and small-scale operational costs. Due to the current global situation, we invite innovative ideas about how collaboration and partnerships can be supported.



The Tripartite Partnership Fund administered by Education New Zealand aims to support New Zealand institutions to develop and grow strong global connections, research links and partnerships for New Zealand, linking to Global Citizens, the third goal of the [New Zealand International Education Strategy \(NZIES\) 2018-2030](#).

## Eligibility Criteria – Who can apply for the funding?

For a proposal to be considered for assessment it must meet the eligibility criteria set out below. Proposals that we consider do not meet these criteria will be declined for funding on eligibility grounds.

The fund is contestable and open to New Zealand universities with existing or new emerging tripartite partnerships. Each university may have more than one such partnership. Proposals must be signed by the applicant and Dean of School or University Research Office.

### Applicants must:

- Be a representative from a New Zealand university
- Have identified and received commitment from two Chinese partner universities
- Confirmed a research project topic and research plan with partners

## Terms of the fund - What Funding is available?

The Fund provides up to NZ\$100,000 including GST per year. Funding will be limited to a maximum of NZ\$20,000-30,000 including GST per proposal. We seek to fund a balance of existing and emerging partnerships respectively.

The assessment panel are looking for innovative ideas and viable solutions to encourage facilitation of partnerships. Some examples of activities and deliverables funded in previous Tripartite Partnership proposals include:

- Increase secure communication platforms or invest in digital technology services
- Translation costs
- Journal Access
- Communication and website platforms

- Professional capability in publishing

The proposal deadline for the Financial Year 2022/2023 round is Monday 01 March 2022. 50% of approved funding will be disbursed on signing of the Funding Agreement, with the remaining 50% to be reimbursed following completion of the proposed activity and associated reporting due within one month (of completion).



## Assessment Criteria

A review panel from Education New Zealand (ENZ), the Ministry of Education (MOE), the Ministry of Foreign Affairs and Trade (MFAT) and the Ministry of Business, Innovation & Employment (MBIE) will evaluate proposals on a two-step basis comprising:

- ✓ Eligibility screen as set by NZ Government policy
- ✓ Alignment of proposed activities with the assessment criteria in the following table.

In assessing the alignment, the proposals will be scored by a panel of assessors from ENZ, MOE, MBIE, MFAT using the following scale:

	Scoring
1	Poor - lacking sufficient explanation or does not respond to assessment criteria
2	
3	Satisfactory
4	
5	Excellent - clear evidence and detailed explanation of alignment to the assessment criteria

Assessors will consider to what extent a proposal provides confidence that the assessment criteria have been met. The scores will be weighted as set out below, to provide a total score out of 20. Proposals will be ranked high to low for funding purposes.

## Reporting Guidelines

Projects must commence on 30 May 2022, and be completed by 30 April 2023. Within one month of completion of the approved activity, Education New Zealand requires a report to be submitted by the applicant detailing how funding achieved the intended objectives as outlined in the proposal. A detailed breakdown of approved expenditure, with appropriate supporting documentation (receipts, etc.), will be required before approved funding can be reimbursed. Interim progress reports following the same format as the final report will be required for proposed activities spanning more than six months.

## Proposal timeline and key dates

The proposal process and timeline is as follows:

Applicants submit funding proposal	01 March 2022
Proposal is checked against eligibility criteria then Assessment Panel reviews with assessment criteria	March - April
Funding decisions announced	01 April 2022
Funding Agreement begin and projects start	30 May 2022
Interim report due	6 months after Funding Agreement signed
Projects deliverables completed	30 April 2023
Report and final invoice due	30 May 2023

## Submitting funding proposals

Completed proposals and supporting documents are due to Education New Zealand by 01 March 2022. The proposal should be emailed as a PDF to the following email address: [china@enz.govt.nz](mailto:china@enz.govt.nz).
